ABORIGINAL PEOPLES IN SOUTHERN AUSTRALIA

- It's where the majority of Aboriginal people live in Australia today, and it has always been the most densely populated part of Australia.
- They formally hold small but significant land holdings, often managed with other interests (e.g. co-managed national parks). Access to publically and privately held lands is important.
- Often live as a minority within diverse intercultural communities
- Complex identity politics
- Knowledge and authority

OBJECTIVES (IN SHORT)

- 1) Investigate current priorities and engagement
- 2) Conduct collaborative research to improve engagement
- 3) Synthesize results for broader policy and practice utilisation
 - → Intercultural Focus
